WCRC's research is focused on the land-climate connection - how changes in land use effect the climate system; how the changing climate is altering systems on land such as forests, ecosystems and agriculture; and what land-management strategies can harness the power of nature to slow climate change. Most of this research is conducted in the arctic and the tropics-critical
