Policy Relevant Research: Scientific excellence is the foundation for all of Woodwell Climate Research Center's activities, and distinguishes WCRC from other NGOs in the environmental sector. Through a holistic, multidisciplinary, applied, and team-focused approach, we seek to create breakthrough understanding of climate change impacts and solutions, for the purpose of informing sound environmental policies from the local to global scale. WCRC's research is focused on the land-climate connection - how changes in land use effect the climate system; how the changing climate is altering systems on land such as forests, ecosystems and agriculture; and what land-management strategies can harness the power of nature to slow climate change. Most of this research is conducted in the arctic and the tropics-critical
